TRS: Crisis Resources for Uvalde CISD and Surrounding Communities

Uvalde CISD:

TRS-ActiveCare is offering additional support and counseling services for Uvalde CISD by activating a temporary cost share waiver for copays and deductibles through June 30 for the following benefits:

Participants covered by TRS-ActiveCare Primary, TRS-ActiveCare Primary+, TRS-ActiveCare HD and TRS-ActiveCare AC2 will have **no costs** for:

- Outpatient mental/behavioral health services in-office services
- Telehealth services for mental/behavioral health

Participants may also:

- Access early refills for prescription drugs, and
- Bypass prior authorizations for certain drugs

Should any participants require care for treatment of injuries resulting from the event, TRS will cover any out-of-pocket costs for medical treatment of such injuries.

Surrounding Communities of Uvalde CISD:

Participants covered by TRS-ActiveCare Primary, TRS-ActiveCare Primary+, TRS-ActiveCare HD, and TRS-ActiveCare AC2 will have no costs for telehealth mental/behavioral health services. Note: The temporary cost share waiver does not apply to inpatient or outpatient hospital services.

Behavioral Health Telemedicine for Employees <u>who do not participate in TRS-ActiveCare</u>:

BlueCross BlueShield of Texas and Teladoc are each committing up to \$50,000 to help fund access to telemedicine behavioral health counseling with licensed therapists and psychologists for **any employee of UCISD and surrounding districts** through the end of June 2022. This will provide services for employees who do not participate in TRS-ActiveCare.

TRS-ActiveCare Mental Health Resources Outside of Crisis Resources (ongoing benefits)

Apart of the crisis resources and benefit enhancements for Uvalde and the surrounding areas, TRS-ActiveCare has robust benefits and resources for mental health care.

TRS-ActiveCare Primary and Primary+ Plans:

- \$30 copays for mental health office visits for in-network providers
- \$70 copay for behavioral health visit virtually through Teladoc

TRS-ActiveCare HD:

- Mental/behavioral services virtually through Teladoc
 - psychiatrist initial visit \$185, ongoing visit \$95
 - psychologist, licensed clinical social worker \$85
